WHEN ARE THE HOLIDAYS?

In a few days we will be replacing the agenda book and the calendar on the wall. That being done, we start flipping pages and ask, "When are the holidays?"

What day does New Year's fall on in 2003? When is the Easter holiday this year? When is the Labour Day weekend? Who decides what we celebrate with a day off and when?

The last answer is somewhat complicated. In Canada three national holidays are set by a Federal law, the *Holidays Act*. However, labour legislation is, largely, within Provincial jurisdiction. In Quebec it is *An Act Respecting Labour Standards* which sets forth the statutory holidays which employers must grant to employees with pay or with compensation in lieu of the holiday and the *National Holiday Act* sets the June 24th holiday. On some holidays stores may be open although employees must be compensated for working on a holiday, but on others customers are not allowed in the establishments (with certain classes of enterprises excepted, and with the number of employees limited). These days are determined by Quebec legislation called *An Act Respecting Hours and Days of Admission to Commercial Establishments*.

These laws define the minimum number of paid holidays for Quebec workers—collective agreements

can add (but cannot subtract) other holidays so long as the employer and union can agree on them. With the laws considered, all Quebec workers will have eight holidays (paid non-work days or days worked with extra compensation) in 2003.

For the sake of comparison, Ontario has nine statutory holidays, as does British Columbia. New Brunswick has six.

In the USA the number of legal holidays varies from state to state. Looking at our nearest neighbours, Maine has 11, New York has 10 or 12 depending on the year (odd or even) and job class, and Vermont has 13. California has 13 or 14 statutory holidays depending on the year.

In the United Kingdom most areas have at least nine public holidays; in France there are 14; in Germany, 11. Throughout all of Australia there are 11 holidays with the states adding between one and three more.

South Africa has 13 statutory holidays; Russia has 12; Sweden has 19.5. In Japan there are 18 holidays but only 7 in China, although Hong Kong has 12 (however the weekend is Sunday only).

AN ACT RESPECTING HOLIDAYS (Canada)

Canada Day 2. (1) July 1, not being a Sunday, is a legal holiday and shall be kept and observed as such throughout Canada under the name of "Canada Day". (2) When July 1 is a Sunday, July 2 is a legal holiday and shall be kept and observed as such throughout Canada under the name of "Canada Day".

Remembrance Day 3. November 11, being the day in the year 1918 on which the Great War was triumphantly concluded by an armistice, is a holiday and shall be kept and observed as such throughout Canada under the name of "Remembrance Day".

Victoria Day 4. The first Monday immediately preceding May 25 is a legal holiday and shall be kept and observed as such throughout Canada under the name of "Victoria Day".

AN ACT RESPECTING LABOUR STANDARDS (Quebec)

Chapter 4. Division III Statutory general holidays.

60. The following days are statutory general holidays:

- (1) 1 January;
- (2) Good Friday or Easter Monday, at the option of the employer, or Easter Sunday for employees working in a commercial establishment that is ordinarily open on Sundays but to which the public cannot be admitted on Easter Sunday pursuant to paragraph 3 of section 3 of the Act respecting hours and days of admission to commercial establishments (chapter H-2.1);
- (3) the Monday preceding 25 May;
- (4) 1 July, or 2 July where the 1st falls on a Sunday;
- (5) the first Monday in September;
- (6) the second Monday in October;
- (7) 25 December

AN ACT RESPECTING HOURS AND DAYS OF ADMISSION TO COMMERCIAL ESTABLISHMENTS (Quebec)

(EXERPT)

3. . . . , the public may not be admitted to a commercial establishment on

- (1) 1 January;
- (2) 2 January;
- (3) Easter Sunday;
- (4) 24 June, or 25 June where the 24th falls on a Sunday;
- (5) 1 July, or 2 July where the 1st falls on a Sunday;
- (6) the first Monday in September;
- (7) 25 December;
- (8) any other day the Government may determine.
